Overview of the Annual Performance Report Development:

Part C SPP/APR Part C SPP/APR Indicator/Measurement Table (OMB NO: 1820-0578 / Expiration Date: 08/31/2014) was used for all indicators with the exception of Indicator 8a-8c. The FFY 2011 APR has been prepared by staff of SC First Steps with the assistance of the Part C Data Manager with the Team for Early Childhood Solutions at the University of South Carolina, School of Medicine. Activities initiated, in progress or completed under SC First Steps leadership July 1, 201 through June 30, 2012 (FFY 2011) are included in this APR.

Monitoring Priority: Early Intervention Services in Natural Environments

Data are from South Carolina early intervention system database, BabyTrac, using data for the entire reporting year, (July 1, 2011-June 30, 2012). Numerator and denominator reflect exclusion of data for children whose service delays were attributed to exceptional family circumstances considered justifiably late, (i.e., family request, illness of child and /or family member, unable to contact family in timely manner despite documented effort of Service Coordinator or Service Provider).

Additional information related to timely initiation of IFSP services:

857 children had a service initiated more than 30 days after IFSP completion due to system noncompliance. This number does not reflect service delays attributed to exceptional family circumstances.

Explanation of Progress:

Data for Indicator 1 collected via the BabyTrac system reflects an improvement in the delivery of timely services for FFY 2011 to 83%. During initial issuance of findings to service coordination agencies, the state system discovered data efficacy problems and was able to achieve resolution through correction and refinement of data system report function capabilities. With input from participating state agencies efforts were made to provide ample opportunity for input of missing data and correction of data by Service Coordinators. Service Coordination Supervisors were given access to the full array of BabyTrac reports in order to ensure data accuracy, timely data entry, and ultimately monitor service coordinator efforts in locating services. As reporting function of the data system has improved, ongoing technical assistance is provided with individual BabyTrac users on a daily basis by Part C Data Manager, Program Managers, BabyNet State Office personnel, and state data system vendor. Additionally, with increased monitoring of data by Service Coordination Supervisors and state system level personnel, data accuracy and timely entry has improved.

Status of Correction of Non-Compliance:

Findings for this indicator for FFY 2010 were issued in October, 2011. Correction verification procedures have been defined as follows:

- 1. <u>Finding rescinded</u>: Current limitations with the BabyNet data system do not allow BabyNet Service Coordination Vendors to supply missing data or correct data entries following a child's exit from the system. Additionally, the data system is designed in such a manner that performance follows the service coordinator, so that when s/he changes employment, findings may be incorrectly attributed to the vendor currently employing the service coordinator rather than the employing vendor at the time of non-compliance. In instances of when non-compliance is identified and the BabyNet Service Coordination Vendor is able to provide sufficient documentation to the BabyNet State Office to indicate the finding based on the the data system is incorrect (for any of the reasons cited above), the finding is rescinded.
- 2. <u>Prong 1 of Correction</u>: BabyNet State Office requests documentation from records for each BabyNet Service Coordination Vendor for whom non-compliance has been identified. For Indicator 1, staff of the state office review the documentation to determine that although late, the service was provided or that the child has exited BabyNet prior to receipt of the service(s). The finding is cleared if the documentation verifies service delivery; the finding remains in place if the BabyNet Service Coordination Vendor fails to provide the requested documentation, fails to submit the documentation within the required time frame (30 calendar days from the date the finding is issued), or submits documentation insufficient to determine if Prong 1 of Correction has been met.
- 3. Prong 2 of Correction: 90 days from the date the finding is issued, staff of the BabyNet State Office regularly review the data of the BabyNet Service Coordination Vendors with findings to determine if children served by the vendor subsequent to the findings are served with 100% compliance. The finding is cleared if no additional instances of non-compliance are identified for a period of 30 days; the finding remains in place if any child served subsequent to the finding has a late service.

66 findings for Indicator 1 were issued in for FFY 2010 performance in 2011. 21 findings, or 32%, were either rescinded based upon challenge of data by BabyNet Service Coordination Vendors with supporting documentation, or were corrected within 1 year of identification.

Of the remaining 45 findings, 5 vendors (8%) have failed to demonstrate either Prong 1 or Prong 2 of correction.

40 BabyNet Service Coordination Vendors (61%) have met Prong 2 of correction by demonstrating 100% performance for children served subsequent to the issuance of findings, but have not yet provided sufficient

documentation for verification of Prong 1 of Correction. South Carolina First Steps to School Readiness continues to work with partnering state agencies and service coordination vendors to submit the requested documentation to verify correction of Prong 1. Additionally, revisions to policies and procedures for FFY 2013 address the responsibilities of both service coordinators and service providers in reaching targeted performance for this indicator.

Discussion of Summary Statements and a-e Progress Data for FFY 2011:

Child Outcomes data for FFY 2011 was reported on all children with completed outcomes data in each category. FFY2010 actual Summary Statement Data was compared to FFY2011 actual Summary Statement Data. Comparisons indicate overall decreases in percent of children exhibiting progress within all summary statements; however, the number of children with reported child outcomes data decreased from last fund year. This could be attributed to the state's change in eligibility criteria during this timeframe which resulted in an overall decrease in the number of eligible children for services and potential collection of child outcomes data. The comparisons revealed that 3a, 3b, and 3c established FFY2011 targets for Summary Statement #1 were not met by the actual FFY2011 data. The comparisons revealed that 3a, 3b, and 3c established FFY2011 data. However, in all 6 Summary Statement #2 were not met by the actual FFY2011 data. However, in all 6 Summary Statements our state data are notably higher than FFY2010 national averages. This could be attributed to data quality increased. We are continuing to get closer to FFY2010 national averages.

FFY2010 a-e Progress Data was compared to FFY2011 Progress Data to look for patterns in data and compare expectations to actual. It is observed for Outcome 3a, 3b & 3c that the largest percent of children who exited "improved functioning to reach a level comparable to same-aged peers" (category d.) in FFY2010 and FFY2011. Outcome 3a, 3b & 3c FFY2010 data and Outcome 3c FFY 2011 data indicate the second largest percent of children who exited "maintained functioning at a level comparable to same aged peers" (category e.); however Outcome 3a & 3b FFY2011 data indicate the second largest percent of children who exited "improved functioning to a level nearer to same-aged peers but did not reach" (category c.). The FFY2011 data reveals a shift in the percentage of children from category e to c being the second largest for two out of three out of the Outcome 3 subcategories in comparison to the FFY2010 data.

Overall, the above data indicates that the Part C program impacted children positively in all three outcome summary categories, even with the decreased number of eligible children being included in child outcomes data sample. There continues to be a need to address data quality issues 1) to ensure that all children who meet the criteria at exit are included in the child outcomes sample and 2) general supervision and continued training to ensure that the child outcomes process is fully understood and implemented correctly for rating decisions. Increasing data quality continues to be an ongoing effort. Additional features were added to the Child Outcomes electronic data base that requires submission of all data components for each Outcome 3 subcategory. There is ongoing monitoring and monthly cross referencing with two databases (BabyTrac and TECS) to reconcile data and ensure that child outcomes data is reported on all exiting children within criteria. Data quality is continuing to be addressed through reports and field work. Child Missing Data Reports are sent monthly to program managers in an effort to capture the children who have no data inputted but should have been in child outcomes data sample. Missing Data Component Reports are frequently sent to program managers not reported within a specific outcome category for children who have all other reported child outcomes data.

These ongoing activities have allowed our state to identify a total 2686 children who met child outcomes criteria at exit and to capture outcomes data on 2087 (78%) of those children at exit.

Discussion of Improvement Activities Completed <u>and</u> Explanation of Progress or Slippage that occurred for FFY 2011:

<u>Improvement Activities</u>- The following activities were completed during FFY 2011; these activities have contributed to the increase in reportable numbers and data quality. Training and TA activities and improved activities with SPOE and Service Coordination have helped to improve the confidence levels of service coordinators with inputting data. Overall monitoring reveals fewer missing data components.

<u>Progress/Slippage</u>- Statewide data reporting continues to move toward being more representative of children served in the state system. On-going training regarding reporting and fidelity of child outcomes data are continued needs within the South Carolina Part C system. Overall, there has been an increased awareness of the child outcomes process and responsibilities of service providers with 1) ongoing follow-up reports to service coordinators regarding return rates and data inputted in both data systems; 2) ongoing training and technical assistance to professional and family organizations concerning child outcomes within BabyNet; and 3) ongoing communication with Interagency Program Managers regarding progress or slippage in child outcomes data activities.

All targets set for FFY2011 were not met for Summary Statement #1 for Outcome 3a, 3b & 3c. All targets set for FFY2011 were not met for Summary Statement #2 for Outcome 3a, 3b & 3c. Overall, decreases in the percent of children exiting not functioning at age expectations maybe attributed to the change in the state's eligibility criteria which has impacted the population of children being served in our system and to overall data quality issues.

Revisions, <u>with Justification</u>, to Proposed Targets / Improvement Activities / Timelines / Resources for FFY 2012: The 2011 FFY's performance will serve as our FFY2012 targets per stakeholder and Interagency Coordinating Council (ICC) input as we continue to monitor impact of state's change in eligibility. These revised targets are included in the amended State Performance Plan.

Description of State Data:

Family Surveys were distributed to all SC families with children with planned and unplanned exits from the Part C system. South Carolina uses the National Center for Special Education Accountability Monitoring NCSEAM family survey which requires Rasch Analysis. Children who had been in the system for less than six months prior to transitioning/exiting due to factors such as relocation, voluntary exits, or deceased were excluded from the data collection process. Surveys were distributed to families within 30 days of a child's exit from the SC Part C system in an effort to improve consistency of contact/address information. Family contact information for mailings was provided by the SC Budget and Control Board, the contractor who manages the Part C electronic data system known as *BabyTrac*. A total of 1437 families met the established criteria for FFY 2010. Of the 1748 mailed surveys, 19% (n=338) returned surveys with 17% (n=303) measurable responses; with

81% (n=1410) being no contact/refused to complete survey (e.g. no responses or from mailer).

Data collected for FFY 2010 is representative of the overall population of children being served and exiting the early intervention system. The data representativeness is expressed at a 95%, +/-5 confidence interval based on the sample population of 1748 children and families with return responses from 338 children and families. The largest percent of children were identified as White (65%, n=220) with Black (23%, n=78) and Hispanic/Latino (4%, n=13) races being next which is representative of state data. The largest percentage of children were enrolled in early intervention services for 6-12 months (46%), with the next largest percentage were enrolled for 25-30 months (20%). This was a shift from last year indicating an overall shorter timeframe of enrolled in our early intervention program.

Discussion of Improvement Activities Completed <u>and</u> Explanation of Progress or Slippage that occurred for FFY 2011:

The targets set for 4a and 4b for FFY2011 were exceeded; however, the target set for 4c was not met. Progress noted with an increased percentage of families in 4a and 4b outcome areas. Slippage was noted with a decreased percentage of families in 4c outcome area. Overall progress noted exceeds the national mean in the Part C SPP/APR 2011 Indicator Analyses (using the NCSEAM standard) in all three areas. Slippage was noted with 4c of this indicator for FFY2011.

Explanation of Progress:

While the performance for Indicator 7 represents a slight improvement from the reported performance of 13% for FFY 2010, significant challenges remain in verifying compliance with the related requirements for this indicator. The performance reported for both FFY 2010 and FFY 2011 represents only those children eligible with established risk conditions for whom the related requirements of completion of the evaluation and assessment activities in 34 CFR §303.322; and hold an IFSP meeting, in accordance with 34 CFR §303.342 can be verified. The BabyTrac data system indicates an additional 1623 children received an evaluation and initial IFSP within 45-days, but the data system does not capture documentation of the child or family assessment.

Status of Correction of Non-Compliance:

Findings for this indicator for FFY 2010 were issued in October, 2011. Correction verification procedures have been defined as follows:

 Finding rescinded: Current limitations with the BabyNet data system do not allow BabyNet Service Coordination Vendors to supply missing data or correct data entries following a child's exit from the system. Additionally, the data system is designed in such a manner that performance follows the

service coordinator, so that when s/he changes employment, findings may be incorrectly attributed to the vendor currently employing the service coordinator rather than the employing vendor at the time of non-compliance. In instances of when non-compliance is identified and the BabyNet Service Coordination Vendor is able to provide sufficient documentation to the BabyNet State Office to indicate the finding based on the data system is incorrect (for any of the reasons cited above), the finding is rescinded.

- 2. <u>Prong 1 of Correction</u>: BabyNet State Office requests documentation from records for each BabyNet Service Coordination Vendor for whom non-compliance has been identified. For Indicator 7, staff of the state office review the documentation to determine that although late, the Initial Individualized Service Plan was developed, or that the child has exited BabyNet services prior to development of the initial IFSP. The finding is cleared if the documentation verifies service delivery; the finding remains in place if the BabyNet Service Coordination Vendor fails to provide the requested documentation, fails to submit the documentation within the required time frame (30 calendar days from the date the finding is issued), or submits documentation insufficient to determine if Prong 1 of Correction has been met.
- 3. Prong 2 of Correction: 90 days from the date the finding is issued, staff of the BabyNet State Office regularly review the data of the BabyNet Service Coordination Vendors with findings to determine if children served by the vendor subsequent to the findings are served with 100% compliance. The finding is cleared if no additional instances of non-compliance are identified for a period of 30 days; the finding remains in place if any child served subsequent to the finding has a late service.

50 findings for Indicator 7 were issued in 2011. 42 findings, or 84%, were either rescinded or corrected within 1 year of identification. Of the remaining 8 findings, Prong 2 has been verified as corrected for 7 or 14% of BabyNet Service Coordination Vendors, with 1 vendor (2%) failing to demonstrate correction for both Prong 1 and Prong 2.

Pending implementation of the state's new data system in FFY 2013, South Carolina First Steps to School Readiness has initiated work with partnering state agencies and service coordination vendors to collect and submit dates for completion of the eligibility evaluation, initial assessment of the child and assessment of the family for each child with a timely initial IFSP, as well as documentation of the disciplines utilized in the eligibility evaluation. This documentation has been received from BabyNet Service Coordination Vendors for FFY 11, and is currently being reconciled with non-compliance and findings identified through the data system.

Concerns are generally heard first by the service coordinator; if they cannot be satisfactorily handled at that level, the matter is forwarded in order (as appropriate) to the supervisor in the service coordinating agency, Program Manager, and BabyNet complaints officer. Throughout the process, the appropriate BabyNet staff is involved in addressing the concern. All *written* complaints received at any level are forwarded to the complaints officer. At that point, every effort is made to resolve the issue without mediation or formal hearing.

All previously described activities designed to make all providers of BabyNet services aware of program policies and procedures contribute to reduction of complaints by assuring that all are aware of program requirements and expectations.

Inter-agency commitment to maintaining lines of communication at multiple levels also contributes to prompt and satisfactory resolution of complaints about the Part C system operation.
