RE: Program and Grants Committee Report for December 6, 2016

The Program and Grants Committee met by teleconference on Monday, December 5, 2016 to review partnership strategy requests and review a set of working recommendations by staff related to evidence-based program implementation for FY18.

The committee brings forward one action item, related to a new strategy request from Chesterfield County First Steps.

ACTION ITEM: Chesterfield New Strategy Request (Nurse-Family Partnership Supports)

With the support of SC DHHS and others, the Nurse-Family Partnership model has recently expanded into Chesterfield County. To support its high-quality implementation, Chesterfield County First Steps proposes to partner with McLeod Health (the program's implementing agency in the region) to support the growth and development of high risk children served by NFP through the provision of supplemental materials to support the model.

Through this small-scale partnership strategy (\$1,700) CCFS will provide developmentally appropriate books and toys for NFP children at key developmental milestones (birth, 3 months, 6 months, 9 months, 12 months, 18 months, 24 months). All newborns will be enrolled in the Imagination Library program, through which they will receive books monthly. NFP will provide CCFS with program information when the parent and child receive the developmental toys or books. When child ages out of NFP, NFP will have CCFS program specialist visit home with NFP nurse to meet mother and child with the goal to connect the child and parent to CCFS services for continuity.

Committee Recommendation: Approval

The Parents Anonymous Program consists of a weekly support group for Parents and Caregivers and a separate group for their Children and Youth (0-18). There is a Trained Facilitator and Parent Group Leader in every Parents Anonymous Group fostering emotional support amongst all participants to improve protective factors, reduce risk, and ensure family stability.
